It assesses all elements of the APM FIVE Dimensions of Professionalism through a single standard, thereby enhancing professional status and recognition. Successful candidates will be entered onto the APM Register of Project Professionals. This demonstrates to users of project management services and the wider public, that these professionals have met the standard for RPP.

## **TARGET AUDIENCE AND PRE-REQUISITES**

The APM Registered Project Professional is available to anyone with a minimum of 8 years experience of managing others in a complex project environment regardless of their professional background or qualifications. All applicants must commit to attending any workshop dates, which will be communicated to eligible applicants before joining the programme.
